# **Tax Information for Non-Resident International Students**

If you were a <u>non-resident</u> alien temporarily present in the US under an F or J visa in 2017, you must file Form 8843.

If you received U.S. source money, you must file Form 1040NR or Form 1040NR-EZ along with the Form 8843.

If you earned money in Pennsylvania, you must file a Form PA-40 and a Local Tax Form.

If you are a <u>resident for federal tax purposes</u> and want tax assistance, you may obtain assistance at the VITA office in the Ferguson Building. Call 814-863-4147 to schedule an appointment.

#### WHAT SHOULD YOU DO?

- 1. Use the software, Winstar FNTR, sent to you by DISSA to complete Form 8843 *and* either Form 1040NR or Form 1040NR-EZ.
- \*\*NOTE: Do <u>not</u> use online tax software such as TurboTax, TaxACT, TaxSlayer, etc. These programs are for <u>resident</u> tax filing.
- 2. If you are a Chinese or Indian student and still have questions, attend one of Global Connection's tax workshops.
- 3. If necessary, sign up for a tax assistance appointment to check your federal form and to complete state and local forms (see below).
- 4. Bring to your appointment: a calculator, pencil, black pen, and a laptop (on which you have already installed Winstar FNTR and attempted to complete your forms)

To make an appointment, come to 314 Boucke <u>in person</u>. *Appointments will not be taken by phone or email.*
